("Mayfair") grants to you ("you" means you and the entity for whom you act as an employee or agent) a nonexclusive, nontransferable license to use one copy of the software program enclosed ("Software") on one personal computer ("PC") in accordance with the terms of this License Agreement ("Agreement"). You may use this Software only by loading it into the computer memory in the PC. You may use the media bearing the Software after loading the Software on the PC for backup purposes only. No other rights are granted to you and all other rights in the Software are reserved to Mayfair. The rights granted to you by this Agreement extend only for so long as you abide by all the terms of this Agreement.

2. **RESTRICTIONS ON USE AND TRANSFER.** You agree not to do any of the following:
- a. Copy any portion of the Software, except to load it into the memory of the PC as authorized in Part 1;
  - b. Transfer any portion of the Software (with or without the PC);
  - c. Rent or lease any portion of the Software;
  - d. Disclose, reverse engineer, decompile or disassemble the Software; or
  - e. Create derivative works of the Software.

You acknowledge and agree that the Software constitutes trade secret information and copyrighted material which is owned exclusively by Mayfair and its suppliers, and any threatened violation of this Agreement shall result in irreparable harm to Mayfair or its suppliers and shall entitle Mayfair or its suppliers to an injunction as well as other legal remedies.

3. **NO WARRANTY/LIMITED REMEDY.** The Software is provided AS IS AND WITH NO WARRANTY. MAYFAIR EXPRESSLY DISCLAIMS THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR PARTICULAR PURPOSE, TITLE AND NON-INFRINGEMENT OF PROPRIETARY RIGHTS. MAYFAIR'S ENTIRE LIABILITY AND YOUR EXCLUSIVE REMEDY FOR ANY ALLEGED DEFECTS IN THE SOFTWARE IS

LIMITED TO REPLACEMENT OF ANY DEFECTIVE MEDIA ON WHICH THE SOFTWARE IS ORIGINALLY SUPPLIED TO YOU. b. This Agreement is governed by the laws of the U.S., State of Ohio without regard to any conflicts of laws provisions thereof. Any legal claim you may present against Mayfair may be presented only in a court located in Summit County, Ohio and you consent to the jurisdiction of such courts.

c. This Agreement constitutes the entire agreement regarding the Software and this Agreement may only be modified in a written document that is signed by the duly authorized representatives of both you and Mayfair. This Agreement shall control over any other agreement or understanding which has any terms that are inconsistent with the terms hereof. If any provisions of this Agreement are held by any court or other authority to be invalid, illegal or otherwise unenforceable, each and every other provision of this Agreement shall remain in full force and effect, except that Mayfair shall have the right at its option to terminate the rights granted to you in Part 1 by sending you written notice.
