20050715 SCAN SOFT END USER LICENSE AGREEMENT

ScanSoft, Inc. (hereafter, "SSFT") owns or has license rights to certain text-to-speech software used in connection with automating telephone-based, network-based, and internet-based interactions.

SSFT agrees to grant to Licensee the right to use SSFT Software as defined below.

By installing or using the SSFT Software, Licensee agrees to be bound by the terms and conditions of this End User License Agreement (the "Agreement"). If the Licensee does not agree to the terms and conditions stated in this Agreement, the Licensee must contact Mayfair Software Licensing, Inc. and arrange to return the SSFT Software and obtain a refund of the licensing fees, if any, paid for the SSFT Software.

TERMS OF AGREEMENT

1. Definitions

The following terms as used in this Agreement shall have the meanings set forth below:

"Documentation" means the operating manuals, user instructions, technical literature, and all other related materials that SSFT may supply to Licensee to facilitate the use of SSFT Software.

"Open Source Software" means the software listed in Exhibit B that is incorporated into SSFT Software.

"SSFT Software" means the software described in Exhibit A, including Open Source Software, in object code format, and all corrections, modifications, enhancements, and updates to such software that SSFT may provide to Licensee under this Agreement or any agreed upon support agreement.

2. Grant of Rights

2.1 Grant of License Rights. SSFT hereby grants to Licensee, and Licensee hereby accepts, a non-exclusive, non-transferable license to use for its business purposes the number of copies of SSFT Software and Documentation

provided to it by the SSFT Distributor in connection with the sale of equipment for which the SSFT Software is intended to be used.

2.2 Copies. Licensee may make a reasonable number of copies of the SSFT Software for Licensee's internal back-up and archival purposes only, provided that all such copies shall bear the original and unmodified copyright, patent, and other intellectual property markings.

2.3 Proprietary Rights; Restrictions. SSFT retains all right, title, and interest in and to the original and any copies of the SSFT Software and Documentation, and all patent, copyright, trade secret, trademarks, and other intellectual property rights therein. Licensee shall not own or have any interest in the SSFT Software or Documentation or copies thereof, but rather is licensed subject to the limits in this Agreement to use such copies. Portions of the SSFT Software may be subject to third party proprietary rights that have been licensed to SSFT. Without limiting the generality of the foregoing, Licensee will not itself, or through any parent, subsidiary, affiliate, agent, or other third party: (a) modify, port, translate, localize, or create derivative works of the SSFT Software or any Confidential Information of SSFT; (b) decompile, disassemble, reverse engineer, or attempt to reconstruct, identify, or discover any source code, underlying ideas, or algorithms of the SSFT Software by any means; or (c) except as expressly permitted by this Agreement, sell, lease, license, sublicense, copy, market, or distribute the SSFT Software;

3. Confidential Information

3.1 Confidential Information. Neither party shall disclose or use the Confidential Information (defined below) of the other party, except in direct connection with this Agreement, for three years following termination or expiration of this Agreement, provided, however, that the foregoing restriction on Confidential Information, which is software, shall be perpetual.

3.2 Definition of Confidential Information. "Confidential Information" means (a) the SSFT Software and any related technology, algorithm, or information contained therein, including related trade secrets; and (b) any other information, such as product plans, sales prospects names, non-published financial information, and discounts/prices, whether disclosed in tangible form or orally if such information is marked or identified as confidential at the time of disclosure or the receiving party reasonably should know is confidential. Confidential Information will not include information that: (i) is in or enters the public domain through no act or fault of the receiving party; (ii) is known to and has been reduced to tangible form by the receiving party at the time of disclosure; (iii) is independently developed by the receiving party without use of or reference to the disclosing party's Confidential Information; or (iv) is lawfully obtained from a third party who has the right to make such disclosure.

3.3 Return of Confidential Information. Upon the earlier of the disclosing party's written request or the expiration or termination of this Agreement, the receiving party shall return or destroy the disclosing party's Confidential Information and certify promptly in writing that it has done so.

4. Limitation and Disclaimer of Damages

4.1 Limitation of Liability. SSFT's total liability to Licensee, its directors, officers, and employees for any claim arising under this Agreement, or the transactions contemplated under this Agreement, regardless of the form of action, will not exceed a cumulative aggregate amount equal to the number of copies of SSFT Software which Licensee is authorized to use times one hundred dollars (\$100).

4.2 NO CONSEQUENTIAL DAMAGES. IN NO EVENT SHALL SSFT BE LIABLE FOR ANY SPECIAL, INDIRECT OR CONSEQUENTIAL DAMAGES, INCLUDING, BUT NOT LIMITED TO, LOSS OF REVENUES AND LOSS OF PROFITS, EVEN IF SSFT HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

5. General Terms

5.1 Governing Law. This Agreement shall be governed by the laws of the Commonwealth of Massachusetts without regard to choice of law rules.

5.2 Export Controls. Licensee agrees and certifies that neither the SSFT Software, nor any other technical data received from SSFT, nor the direct product thereof, will be exported or re-exported outside the United States except as authorized and as permitted by the laws and regulations of the United States
